**AFFIDAVIT**

**(Representations and Warranties)**

2. I accept all the rules established by IDP in the IDP Bylaws, which I have read and understand.
3. Notwithstanding any other provisions of any other document or any other representations that have been made to me by anyone, I agree that if in its sole determination IDP concludes I have made any material misrepresentations concerning my person or my legal status in this country, IDP shall be entitled to revoke my membership in IDP without any further recourse by me.
4. I understand that IDP may assign me as a Senior Pastor or in any other capacity to an IDP church. I understand that IDP is the sole and exclusive owner of any and all property of any kind, including vehicles, office equipment, musical instruments, donations, gifts, offerings, sound equipment, checking accounts, savings accounts, buildings, land, and all other tangible or intangible personal or real property, that I may receive, or come into possession of, in my capacity with the IDP church, including any property acquired by me for an IDP church or on behalf of IDP with the use of IDP funds or IDP property (herein "IDP Property").
5. If I am placed on title or obtain any other incidents of ownership of any IDP Property, including but not limited to vehicles or real property, I warranty that I shall be acting as trustee of such IDP Property on behalf of IDP.
6. I warranty that prior to the purchase or sale of any IDP Property with a value of more than \$500.00, I will obtain written permission from the IDP Regional Board of Directors.

7. I warranty that prior to any expenditure of IDP funds greater than \$3,000, I will obtain written permission from the IDP Regional Board of Directors.
8. I warranty that in the event my relationship with IDP is terminated, whether voluntarily or Involuntarily, or upon request to me by the IDP Regional Board of Directors, I will immediately return all IDP Property to IDP.
9. I warranty that in the event my relationship with IDP is terminated, whether voluntarily or involuntarily, or upon request to me by the IDP Regional Board of Directors, I will cooperate in the transfer of title or other incident of ownership of an IDP Property held in my name to IDP, as directed by the IDP Regional Board of Directors.
10. I warranty that I have read and accept and agree to be bound by the IDP Code of Ethics of IDP as set forth in the IDP By-Laws.
11. I understand and represent that in the event I violate any of the warranties made by me in this document, IDP will suffer immediate and irreparable harm and shall be entitled to all relief under the laws of the State of California, including but not limited to any and all provisional remedies as appropriate, including temporary restraining orders, immediate injunctive relief and/or a writ of attachment.
12. IDP may have assisted me with respect to my immigration status in the United States. If so, if my relationship with IDP is terminated or otherwise modified, IDP reserves the right to notify either the Immigration and Naturalization Service or any other governmental agency as required by law.
